# CONDITIONS OF ENTRY

The application included on the reverse side hereof is subject to acceptance by the PNW Section, PGA of America, and applicant agrees that in the event of its acceptance, it may be rejected or revoked at any time thereafter. To be accepted, entries must be signed, paid, and received at Tournament Headquarters. Therefore, players submitting entries are encouraged to allow ample time for delay or error in transmission of their entries.

Both the said Application and Applicant's participation in the aforesaid Invitational Championship (hereafter referred to as the "Championship") are subject to all Rules, Regulations, provisions of the Constitution and By-Laws of the Pacific Northwest Section, PGA of America and other conditions applicable to the Championship, as well as to the terms and conditions of the agreement between the PNW Section, PGA of America and the Championship sponsor(s) with respect to same.

NON-METAL SPIKE RELEASE: If it is the requirement of the Host Club that all individuals using the Host Club golf course wear spikeless/non-metal golf shoes. This requirement is a policy of the Host Club and is not a policy of the Pacific Northwest Section of the PGA of America ("Section"). The use of spikeless/non-metal golf shoes may result in the participant slipping on wet or damp surfaces (inclusive of but not necessarily limited to turf area, wooden areas such as bridges and pathways, etc.) and reduced traction on non-level areas of the golf course. As evidenced by the participant's signature on the front of this entry, the participant acknowledges that potential dangers relative to the use of spikeless/non-metal golf shoes have been disclosed to participant and participant agrees to assume the risk of sustaining injury arising from or attributable to the use of spikeless/non-metal golf shoes at the Host Club's premises. The participant here releases the Section and Section's officers, directors, members, employees, successors and assigns (the "Indemnified Parties") from any and all claims for loss damage, inclusive of but not limited to personal injury, whether or not caused by participant's use of spikeless/non-metal golf shoes at the Host Club's premises in connection with the tournament. The consideration for this release is the permission granted by Section to the participant to participate in the golf tournament. This release binds not only the participant, but also the participant's spouse, heirs, legal representatives, and assigns.

By this application, an applicant consents to references to him and pictures of him and his play in any publicity, radio and television broadcasting and other exhibition or publication, including their use in any commercial manner.

**ELIGIBLE PLAYERS:** The term "eligible player" is defined, for this Championship, as: (1) all Pacific Northwest Section, PGA of America members (except those classified as "F" or "Reserve"); (2) all PNW Section, PGA of America associates with full Section Playing Privileges; (3) amateurs as defined by the USGA. **All players must reach their 50th birthday on or before July 28, 2020**. Contestants entering as amateurs may not accept professional prize money. Section 5 of the Tournament Regulations applies.

Entry priority will be as outlined in Section 8 of the PNW PGA Tournament Regulations.

#### FIELD: 56 teams

**STARTING TIMES**: Groupings will be available at the Section Office by Wednesday, July 22 or online at the Section website at <u>www.pnwpga.com</u>. Competitors are responsible for knowing their starting time and tee. Players will not be called to their starting tee.

#### **COMPETITORS:**

**Championship**: All competitors are competing in a 54-hole stroke play championship based on gross score.

**Individual Net:** There will be a limited Net purse based on the 54-hole score.

**Professional Super Senior:** All professionals 63 and over are competing in a 36-hole stroke play championship over the first two days of the Championship, based on gross score only. No double dipping.

**Pro-Am:** All competitors are competing in a concurrent 36 hole proam over the first two days of the championship. It is scored using two best balls of the four, one gross and one net, at 90% handicap. **NO CUT IN 2020!** 

Players MAY WITHDRAW between rounds for any reason and you are welcome to do so. If you prefer not to play the final round, you must notify a member of the PGA staff BEFORE THE LAST ROUND 2 SCORE IS POSTED.

As a last resort, weather conditions may force us to impose the customary cut of 84 lowest gross scores.

NOTE: Amateurs are limited to winnings of \$750 for the entire championship.

**HANDICAPS:** The individual championship is gross. In the individual net and team competitions a maximum course handicap of 18 will be used. Players higher will play to a 18. Players without active USGA indexes will play at SCRATCH.

DRESS CODE: Contestants may not wear jeans.

**PRACTICE ROUNDS:** Contact the host site for availability. Wildhorse Resort & Casino: 541-276-5588.

**HUDSON CUP POINTS:** The appropriate Senior Hudson Cup points will be granted by the Section, OGA, and WSGA for this event.

**SEPARATE TEE POLICY:** Although competing from separate tees, men and women shall compete for the same purse.
