



# PNW SECTION SENIOR PGA CHAMPIONSHIP

## OPTIONAL PRO-AM – SEPT 1/CHAMPIONSHIP – SEPT 2-3

### CONDITIONS OF ENTRY

The conditions of entry are set forth by the PGA of America and are detailed on the entry information supplied to prospective entrants by the PGA of America. Information supplied by the PNW Section is informative in nature and is not binding on the conduct of the championship.

**NON-METAL SPIKE RELEASE:** If it is the requirement of the Host Club that all individuals using the Host Club golf course wear spikeless/non-metal golf shoes. This requirement is a policy of the Host Club and is not a policy of the Pacific Northwest Section of the PGA of America ("Section"). The use of spikeless/non-metal golf shoes may result in the participant slipping on wet or damp surfaces (inclusive of but not necessarily limited to turf area, wooden areas such as bridges and pathways, etc.) and reduced traction on non-level areas of the golf course. As evidenced by the participant's signature on the front of this entry, the participant acknowledges that potential dangers relative to the use of spikeless/non-metal golf shoes have been disclosed to participant and participant agrees to assume the risk of sustaining injury arising from or attributable to the use of spikeless/non-metal golf shoes at the Host Club's premises. The participant here releases the Section and Section's officers, directors, members, employees, successors and assigns (the "Indemnified Parties") from any and all claims for loss damage, inclusive of but not limited to personal injury, whether or not caused by participant's use of spikeless/non-metal golf shoes at the Host Club's premises in connection with the tournament. The consideration for this release is the permission granted by Section to the participant to participate in the golf tournament. This release binds not only the participant, but also the participant's spouse, heirs, legal representatives and assigns. By this application, an applicant consents to references to him and pictures of him and his play in any publicity, radio and television broadcasting and other exhibition or publication, including their use in any commercial manner.

**ELIGIBILITY:** Open to all PNW Section Members except those classified as "F" or "Reserve" who will reach their 50<sup>th</sup> birthday on or before October 21, 2021. To qualify for Section purse, 50<sup>th</sup> birthday must be on or before September 2, 2021.

**STARTING TIMES:** Groupings will be available at the Section office by Friday, August 28 at the Section website at [www.pnwpga.com](http://www.pnwpga.com). Competitors are responsible for knowing their starting time and tee. Players will not be called to their starting tee.

**DRESS CODE:** Contestants may not wear jeans in the championship.

**SENIOR PGA CHAMPIONSHIP QUALIFYING:** This event is also qualifying for the 2021 Senior PGA Professional Championship presented by Cadillac, held October 21-24, 2021 at PGA Golf Club in Port St, Lucie, FL. The top 5 qualifiers will advance. You needed to have signed up with National by the entry deadline on Wednesday, August 18 at 1:00 pm.

**SEPARATE TEE POLICY:**

Although competing from separate tees, men and women shall compete for the same purse.

 Friday, September 3: Round 2 – tee times starting at 7:30 AM

**FORMAT:**

Players choose their division – Championship at 6,337 yards or Senior at 5,932 yards. Senior PGA Professional qualifiers, those wishing to earn Hudson Cup points, and those wishing to win the championship must play in the Championship division.

Players selecting the Senior division will play the Senior tees and compete in one division with the purse split equally between gross and net.

Payout – the distribution of money between the Championship division and the Senior division will be determined by the number of entries in each. Any added money will be split equally between divisions.

Groupings will be by division for the first round and by division and gross score for the second round.
